Profile: Overview

Tom Dumont has three decades of experience to draw on. In most of these cases, Tom has been against QCs, and beaten them. Tom has acted in leading cases in various fields including the development of constructive trusts, and the rule in Hastings-Bass. He is currently instructed on behalf of a family with substantial land interests valued in 9 figures, on a variation of their trusts to cover the next two generations.

He is a member of the ACTAPS committee, and chair of the STEP Journal Editorial Board. He is a frequent lecturer and commentator on legal matters, and presents the Lexis Nexis' Private Client webinars.

daughter works for UNICEF. His son is in the Army. His father was a solicitor, but the legal line seems to have come to an end.
