Before starting pupillage at Radcliffe, Amber worked at Advocate as their first Commercial Chancery Caseworker. She remains committed to involvement in pro bono work.

CIVIL FRAUD

Examples of work include:

Appearing, led by Alec Haydon KC, in a civil fraud claim heard over 12 weeks in the Commercial Court. Amber was part of a team of counsel representing the Claimants in a complex claim for breach of fiduciary duty, conspiracy and dishonest assistance/knowing receipt. The trial saw cross-examination of numerous factual and expert witnesses.

COMMERCIAL

Examples of work include:

- Advising on the enforceability of an arbitration award in the High Court.
- Appearing in strike-out, set aside and summary judgment applications.
- Appearing in trials on the Small Claims Track.
- Appearing in a Part 18 application.
- Appearing in applications under s859F of the Companies Act 2006.
- Drafting statements of case in contractual disputes.

As a pupil, Amber also observed and considered issues relating to share purchase agreements, as well as rectification of a company's register of members following the death of a sole director and shareholder.

INSOLVENCY

Examples of work include:

- Appearing in bankruptcy petition.
- Appearing in winding-up petitions.
- Appearing in application under s216(3) of the Insolvency Act 1986 (restriction on re-use of company names).
- Appearing in an application for annulment of a bankruptcy.
- Appearing in an application for extension of an administration.
- Appearing in an application relating to the remuneration of office-holders.

PRIVATE CLIENT

Examples of work include:

- Advising on and appearing at a hearing concerning the removal of an executor under section 50 of the Administration of Justice Act 1985.
- Advising on and drafting a Defence and Counterclaim in a challenge to the validity of a Will.
- Advising on the correct interpretation of a Will.
- Advising on dealing with an estate where one of the beneficiaries could not be found.

As a pupil, Amber also observed and considered issues relating to Nil Rate Band Discretionary Trusts, intestacy and domicile, charitable trusts and permanent endowment, and variation and rectification of Wills.

PROPERTY

Examples of work include:

- Acting, led by William Moffett, in [Savage v Savage \[2024\] EWCA Civ 49](#), a case concerning the correct interpretation of section 15(3) of the Trusts of Land and Appointment of Trustees Act 1996 (TOLATA).
- Advising on and drafting Particulars of Claim for an order for sale under section 14 of TOLATA.
- Appearing in possession hearings (rent, mortgage, forfeiture, and trespass cases) and related applications (including an application to transfer proceedings to the High Court).
- Appearing in the First-tier Tribunal in lease extension and service charge cases.
- Appearing in charging order applications.
- Drafting legal submissions for the First-tier Tribunal in a breach of covenant claim.
- Advising on whether a demand for service charges was validly constituted under a lease.
- Assisting (as a pupil) with advice on the status of an historic Rent Act tenancy.
