COMMERCIAL

Chris is a leading barrister for commercial litigation, with a particular specialism in cases involving allegations of fraud and financial wrongdoing. He is frequently instructed in cases involving multiple jurisdictions and complex corporate structures. His experience in company and insolvency disputes makes him exceptionally well-placed to advise on tracing, enforcement and asset recovery issues. He has extensive experience obtaining interim remedies, including freezing and proprietary injunctions, search and disclosure orders, the appointment of interim receivers and, where appropriate, provisional liquidators.

Chris' recent work includes

- Bringing a £12 million professional negligence claim against a fund manager, defending an accountancy firm against a multi-million claim for negligent misstatement and acting for a former bank employee in a £36 million conspiracy claim.
- Acting for the liquidators of a property fund in a £10m professional negligence claim against its manager, for an investment fund defending a claim by an introducer seeking £6m in commission, for an investor in a

bridging loan business claiming £8 m under guarantees, and for PIP claimants in a £15m professional negligence claim against a defendant's solicitors and counsel.

BANKING

Chris worked in derivatives before becoming a barrister, so he understands the issues faced by financial institutions and their advisers. Chris acts regularly for banks and borrowers in international finance and secured lending disputes. He has particular expertise in security instruments, including asset mortgages and company charges. He offers wide-ranging experience including of crypto-currencies, international payments, commodities and guarantees.

- Acting for Lloyds Bank in a claim under an asset finance indemnity, for Credit Suisse in a foreign currency mortgage mis-selling claim, and for Brown Shipley and KBL in a £68 million breach of duty and conspiracy claim.
