**Gordon Nurse** is a leading commercial and chancery practitioner with a particular interest in sports regulation. He is the Disciplinary Commissioner of the International Hockey Federation and Chair of the England Hockey Appeal Panel. His practice ranges from multi-million-pound disputes in the Commercial Court to applications for statutory wills in the Court of Protection, and including most areas of the law normally litigated in the Chancery Division. His experience as a Deputy Chancery Master enables him to provide a clear and practical approach to litigation and procedure.

His advice in sporting matters include the drafting of club constitutions, the obtaining of charitable status by organisations concerned with sport, as well as the drafting and enforcement of disciplinary regulations. He was a member of the Hockey Jury of Appeal at the 2012 and 2016 Olympics.

#### PROPERTY

Gordon Nurse has considerable experience and expertise in advising on and litigating real property matters - including Landlord and Tenant, both residential and commercial. Recent cases include *Smyth-Tyrrell v Bowden* [2018] EWHC 106 (Ch).

#### WILLS, ESTATES AND TRUSTS

A significant proportion of Gordon Nurse's practice has been concerned with the administration of estates and the duties of executors and trustees, as well as disputes over the validity and construction of wills.

#### CHARITIES

Gordon Nurse advises and drafts documents concerned with charitable activities. He was a member of the Charity Law Association's sub-committee reporting on the Charity Commission Consultation on the Promotion of Amateur Sport. He has represented charities in litigation concerned with property owned by charities, as well as gifts and bequests to charity.

#### COMMERCIAL DISPUTES

Gordon Nurse's practice has included a multi-million-dollar banking case

concerned with allegations of conspiracy and constructive trusts, with a six-week hearing in the Commercial Court, and a wide range of disputes involving both individuals and companies.

Gordon Nurse's practice has included advising on and litigating about minority shareholders rights, and he has a particular interest in the use of corporate entities for charities promoting sport.

## **COURT OF PROTECTION**

Gordon Nurse advises on applications for statutory wills, and issues concerned with mental capacity.

Gordon Nurse has regularly advised on and represented both claimants and defendants in professional negligence claims against barristers, solicitors and accountants.

## **MEDIATION AND ARBITRATION**

Gordon Nurse has a very practical approach to alternative dispute resolution and experience of representing clients before diverse quasi-judicial bodies, including, for example, the Solicitors Disciplinary Tribunal and the Showmen's Guild.

He has also regularly adjudicated on disciplinary matters and other disputes concerned with hockey in his capacity as Chair of the England Hockey Appeal Panel, and Disciplinary Commissioner of the International Hockey Federation.
